PROPOSITION 1 (Budget)

Shall the Board of Education of Medina Central School District of the Towns of Ridgeway, Shelby, Barre and Albion, Orleans County, Hartland, Niagara County, and Alabama, Genesee County, New York, for the fiscal year commencing July 1, 2021 and ending June 30, 2022, be authorized to make the expenditures of the monies set forth in the \$39,323,374 proposed budget submitted to the Annual Meeting on May 10, 2021, and levy the necessary tax therefor?

BOARD MEMBER CANDIDATES
